



### ABOUT RALPH W. VOORHEES

Ralph W. Voorhees was a 1948 graduate of Rutgers University, where he was a member of the Phi Beta Kappa honorary society. Mr. Voorhees was senior vice president for investments at Paine Weber, served as a member of ASA Holdings Inc.'s Board of Directors, and as chairman of the boards of the United Way of Central New Jersey, Family Counseling Services of Middlesex County, the Robert Wood Johnson University Hospital, and the New Brunswick Cultural Center. At Rutgers, he was chairman of the University Foundation and served on the University Foundation's Board of Overseers.

He was inducted into the Rutgers Hall of Distinguished Alumni and received the Presidential Recognition and the Loyal Son of Rutgers Awards. He served as a member of the Voorhees College Board of Trustees where he received the Keeper of the Flame Award for continuing his family's legacy of supporting the college.

Mr. Voorhees lived in Highland Park, NJ where his activities spanned health, urban renewal, and education and then in New Brunswick. A sterling example of volunteerism and civic engagement at its very best, Mr. Voorhees dedicated many years to service in several areas of university and community life, demonstrating vision, unquestionable altruism, and outstanding success as a philanthropic leader.




# THE VOORHEES FELLOWS

### **VOORHEES FELLOWS PROJECT**

### UNDERSTANDING THE ROLE OF HOUSING NAVIGATORS





The Ralph W. Voorhees Public Service Fellowships are awarded annually to students who have chosen to focus their academic pursuits on civically-engaged learning through research projects in community development and planning, community-based education, entrepreneurship, housing, public transportation, public health, or public policy.

This year, five Ralph W. Voorhees Public Service Fellows worked with New Community Corporation, a community development organization in Newark, New Jersey, and NCC's emergency shelter Harmony House, to research <u>housing navigation</u>. Part of a Rutgers Equity Alliance for Community Health (REACH) community engaged project, the Fellows researched how housing navigation is done around the country today.

### ABOUT THE VOORHEES FELLOWS

Bernice Amankwah is a senior majoring in Health Administration at the Edward J. Bloustein School of Planning and Public Policy. 
### ABOUT THE VOORHEES FELLOWS



# STUDENT RESEARCHER PROFILES

### **ZEHRA MAHDI**

I am a Fulbright Nehru Visiting Doctoral Fellow at Bloustein School and a PhD candidate at Department of Architecture and Regional Planning, IIT Kharagpur, India. My research focuses on neighborhood change in informal settlements in Delhi, India that are predominantly inhabited by the Muslim community and influenced by the presence of anchor institutions. I focus on internal heterogeneity in the settlement through visual geography and oral research tradition.

During my Fulbright year at Bloustein, I have been fortunate to be mentored by Dr. Andrea Restrepo-Mieth. We explored the role of informal institutions in urban property in Global South by utilizing our fieldwork experiences from Indian and Latin American cities.

My time at Bloustein has been intellectually stimulating and rewarding. Dr. Newman, Dr. Restrepo-Mieth, and Dr. Mian have shown me incredible warmth, making sure I was included in departmental events. Professor Restrepo-Mieth helped me refine my research questions and provided direction for my future academic endeavors. I was touched when the Voorhees Centre for Civic Engagement organized a talk on my research, giving me the opportunity to share my work with mentors and a diverse audience—it was truly exciting!



During the Fall Semester, Wednesdays were my favorite as I looked forward to attend Professor Mike's Pizza Colloquium. I met fellow PhD students and mentors as we shared experiences, ranging from writing challenges to scholarly activism. My fondest memory is attending the UAA Conference in Vancouver with Bloustein professors and peers. It felt wonderful to be part of an academic community and learn about everyone's research.

I am grateful to Fulbright for the opportunity to visit Rutgers. This fellowship has provided me perspective to situate my ongoing research in a broader context and opened avenues for multidisciplinary research in planning and policy domain. What I cherish the most are the incredible people I met and the time that we shared—these connections have created a meaningful community that will continue to inspire and support me long after my fellowship ends.

### **SOPHIA FOX-DICHTER**

Before entering the doctoral program at the Bloustein School, **Sophia Fox-Dichter** worked as a data analyst at the Social Policy Institute of Washington University in St. Louis. Her research there focused on employee financial wellness programs as well as housing stability. For the past few years, she has assisted Dr. Andrea Hetling in researching safety net programs such as Temporary Assistance for Needy Families, the Supplemental Nutrition Assistance Program, and TANF-funded housing youchers in New Jersey.



Sophia has taught or assisted in teaching courses on quantitative and qualitative methods, employing both in her research. At Rutgers, she is part of the Institute for Teaching, Innovation, and Inclusive Pedagogy, leading workshops in pedagogy for fellow doctoral students and postdoctoral scholars. In the future, she intends to continue researching rental housing and social safety net policies.

Sophia spent the Spring preparing her dissertation proposal to study good cause eviction laws in the Hudson Valley of New York State as well as working on a study of administrative churn in New Jersey's SNAP caseload. Over the summer, she will co-lead the New Jersey State Policy Lab's internship program.

### FACULTY PROFILES

### **EMILY PARKER, ASSISTANT PROFESSOR**



I am a sociologist and demographer studying how, when, and where public policies and local community contexts matter to the longstanding links between health, poverty, and inequality. My primary research focuses on the Community Health Center program, which serves more than 31 million predominantly low-income Americans in medically underserved areas. I use mixed methods to examine the political historical development of this program since the 1960s, the qualitative experience of patients attending safety net clinics, and how the program has impacted population health disparities in the United States.



# RWV CENTER RESEARCH PROJECTS

### FAITH-BASED AFFORDABLE HOUSING

Nadia Mian was awarded grants from the Duke Endowment and Trinity Church Wall Street to build a publicly accessible faith-based affordable housing database that catalogues congregation-led affordable housing constructed on religious property since 2015 in the United States. MCRP student Cybil Bailey and Voorhees Fellow alum Marcelo Remond are part of the research team.

Dr. Mian is also working on a paper examining Seattle's faith-based density bonus as part of a Research Fellowship from Villanova University, and she is conducting an analysis of Yes in God's Backyard (YIGBY) legislation being implemented across the country.

Dr. Mian was invited to join the Research Council for Releven, a faith-based non-profit organization and the Congregational Futures Collaborative working group, an interdisciplinary set of researchers from across the country focused on congregations and land.

### **NEW JERSEY STATE OF AFFORDABLE RENTAL HOUSING (NJSOARH)**

A <u>new report</u>, led by former postdoctoral associate Shiloh Deitz (now a professor at St. Louis University), examines the stock of federally subsidized rental units in New Jersey. It investigates how federal housing priorities have shifted over time and how those shifts have reshaped the composition of federally subsidized housing units in the state.

Matt Mleczko is drafting a report on the strategies US local governments use to facilitate affordable housing production and preservation.

Will Payne is working on a graphic tool for quickly summarizing housing market conditions across the state's many municipalities.





### TRANSFER OF DEVELOPMENT RIGHTS

With a grant from the Progress & Poverty Institute, Professors Mi Shih and Kathe Newman, doctoral students Yu Wang and Bridget Fisher, and masters student Amara Thompkins are exploring transfer of development rights (TDR) in Taipei, Taiwan and New York City. They are interested in the decision making processes that enable TDR and how communities decide how development will impact communities.

### **URBAN STUDIES FOUNDATION - KNOWLEDGE MOBILIZATION GRANT**

Professor Mi Shih and doctoral student Yu Wang's Knowledge Mobilization Grant-funded work sought to engage in diverse forms of knowledge mobilization and to create a digital life for the public engagement work building on the theme of Mi Shih's <u>previously funded Urban Studies seminar</u> series about the politics and value of land. While they continue their research, Professor Shih and Ms. Wang have been exploring and testing visualization ideas that transform research outputs into more accessible and stimulating formats such as a website.

### CORPORATE OWNERSHIP OF 1-4 UNIT PROPERTIES IN NEW JERSEY

With the support of the New Jersey State Policy Lab, Eric Seymour and Will Payne are expanding their research on corporate ownership across New Jersey to obtain a complete view of corporate ownership in one-to-four-unit residential properties. This project examines the causes and context of increasing corporate and overall investor ownership between 2012 and 2022, including histories of foreclosure, and will discuss implications for housing access and affordability in affected neighborhoods and municipalities.

### HOME MORTGAGE LENDING IN CAMDEN, NJ

Katharine Nelson (Rutgers University - CLiME), Kathe Newman, Lauren Nolan, and Eric Seymour are studying access to home mortgages in Camden in partnership with St. Joseph's Carpenter Society and funding from the Rutgers Equity Alliance for Community Health (REACH). The team is analyzing Home Mortgage Disclosure Act data and conducting interviews to better understand access to quality home mortgage credit and patterns of home purchase, refinance, improvement mortgage originations and denials in the period 2018-2022.

### HOUSING NAVIGATION

Postdoctoral Associate Matt Mleczko detailed the emergence and evolution of housing navigation and reviewed the decades worth of evidence regarding its effectiveness in a recent working paper. He argues that this history of housing navigation provides important context regarding the historical analogues of contemporary housing problems and solutions in the US. The evidence strongly indicates that housing navigation promotes housing stability, desegregation, and social mobility, but the long-term success of these programs will likely rely on more upstream, structural reforms that address the root causes of housing instability and that, like housing navigation, have roots in the past. With Professors Dan Treglia and Kathe Newman, he's also working on a project to further support housing navigation efforts at New Community Corporation in Newark, NJ.






### PERSISTENT BARRIERS TO INTEGRATION IN 'HIGH-OPPORTUNITY' AREAS

Assistant Professor Bernadette Baird-Zars presented work at the Urban Affairs Association and at the Bloustein Research Seminar series on the initial findings of four case studies on residents of subsidized housing in 'opportune' areas. This spring, six Bloustein undergrad and master students continued work on the team and contributed useful insights and creativity that helped fuel nuanced findings on the persistence and prevalence of barriers from the physical environment, cost and school systems to 'full' access by low-income residents, with larger implications for understanding equity and integration. In late April, the team was disappointed to learn that the NSF grant funding this project was terminated.

### **NEW JERSEY COMMUNITIES AND FLASH FLOOD ADAPTATION**

Dr. Bernadette Baird-Zars, undergraduate Sean Lamb, and MRCP student Amara Thompkins' research on flash flood modelling for New Jersey that incorporate non-traditional and community data was presented at the American Association of Geographers. Dr. Baird-Zars also participated in a roundtable there on coproduction and climate adaptation, where she discussed her ongoing collaboration with the New York City-Environmental Justice Alliance through the Resilient Coastal Communities Project. Dr. Baird-Zars is also on the advisory board of an EPA-funded project to help design community-engaged flood and pollution information systems in New Jersey's frontline communities.


### RWVC TALKS WITH ZEHRA MAHDI TUESDAY FEBRUARY 11, 2025





On Tuesday February 11th, Zehra Mahdi discussed "Mapping Neighborhood Boundaries in a Muslim Informal Settlement: Case of Jamia Nagar, Delhi, India." Muslim spaces in India are often characterized by a socio-spatial bundle of attributes enmeshed in planning informalities. They are frequently viewed through a lens of opaqueness and homogeneity by the State, planners, policy-makers, and other residents. Such a generalization of space leads to stigmatization and uneven distribution of State resources. This talk illustrates the internal heterogeneity and dynamics of socio-spatial organization within Muslim spaces. It examines how residents define their neighborhoods by evoking spatial and non-spatial variables of distinctions, and how their perception and delineation of neighborhoods differ based on their positionality. It then provides a method to reach consensus from multiple, overlapping boundaries to operational neighborhood units. It is an attempt to move beyond the binaries of formal-informal, religious, and ethnic groups as black-box typifications in urban spaces, and to counter map admin-political boundaries 'from below' by accounting for residents' sensibilities, agency, and consensus.




# INTO THE FUTURE
